

# Girl's family grieving over fatal house fire

## ■ Man with a history of arson arrested in case.

A Logansport family has been on an emotional roller coaster since an April 6 fire in Cedar Rapids, Iowa, claimed the life of 6year-old Jaymie Grahlman.

Jaymie, the daughter of Shannon Salmons, of Logansport, died on April 7 from injuries sustained in the fire. Her father, Jay Grahlman, formerly of Logansport, died April 9, also from firerelated injuries.

Salmons and Grahlman had joint custody of their daughter. And in fact, said Jaymie's maternal grandmother Kay Salmons, she and Shannon were scheduled to go to Iowa the week after the fire to pick up Jaymie for an extended stay in Logansport.

The fire at the Grahlman home

broke around midnight on April 6. Other occupants of the house at the time, Vickie Reed. Grahlman and children Kylie Reed, Nicole Reed,



Grahlman, escaped the burning house. Reed-Grahlman was treated for smoke inhalation.

Firefighters found Jaymie in a bathtub inside the burning home. She died later on the 7th in University Hospitals, Iowa City.

"As a grandmother, I know how I feel. I can't imagine how her mother feels. Some days Shannon does OK, but most days are hard for her."

The family learned recently that an arson arrest has been made in connection with the fire.



Zirtman reportedly had a history of setting fires in the very neighborhood where the fatal fire occurred.

Jaymie's Logansport family has not had an easy time of it since the little girl's death, according to Kay Salmons.

Along with dealing with the pain of losing Jaymie, Shannon Salmons had to obtain a court order to bring her daughter back to Logansport for burial. The order was filed by attorney Mike Boonstra and signed by Judge Julian Ridlen, Kay Salmons said.

Seven days passed between the time Jaymie died and the day she was buried in Ever-Rest Memorial Park Cemetery, Salmons added.

And according to Salmons, laymie never should've been taken to Iowa to live. Since Jaymie's parents shared custody, Jay Grahlman was supposed to have written permission from Shannon Salmons to take the little girl out of state. That never happened, said Kay Salmons. Although she couldn't remember exactly how long Jaymie had lived with her father in Iowa, Mrs. Salmons said she thought it had been at least one year.

A memorial fund has been established in Jaymie Grahlman's name at Security Federal Savings Bank in Logansport.


