Official tells panel

Panama is neither open nor repressive

WASHINGTON (UPI) - Military strongman Omar Torrijos rules Panama virtually by himself but does not preside over "a repressive, totalitarian government," a State Department official told a House committee today.

The American widow of a man who burned himself to death to protest alleged repression by Torrijos testified

differently before the House International Relations committee. Torture, she said, is not uncommon.

The House panel and the Senate Foreign Relations committee heard testiony on the controversy over whether to turn the

Panama Canal Torrijos over to Panama in the year 2000. Critics have charged he waterway could be an explosive international tool in the hands of a dictator.

"Our own assessment at the present time is that Panama is neither a model open society, a traditional liberal democracy, nor a repressive, totalitarian government," State Department spokesman William P. Stedman told the House committee in support of the canal treaties.



"Cuba is the Soviet anchor in the Caribbean in defiance of the Monroe Doctrine," Moorer said, and warned:

"Do not be surprised - if this treaty is ratified in its present form — to see a Soviet and or Cuban presence quickly established in the country of Panama.'

Zumwalt, former chief of naval operations, acknowledged the possibility the Soviet Union may win power over the canal, but he argued that rejection of the controversial treaties was more likely to increase Soviet influence than to hinder it.

"The loudest cheers will be in Havana and Moscow" if the treaties are rejected, Zumwalt told the committee. He added:

"I believe it is possible the Soviet Union will have control over the canal as U.S. military continues to deteriorate. But I believe it will take them longer to gain control" if the treaties are approved.

The committee heard other warnings of Soviet encroachments Monday from four canal zone civic leaders.

- The Soviet Union plans to build a hydroelectric plant, a bank and a shop - Panamanian students regularly

go to the Soviet Union or to Cuba for studies.

- Soviet planes fly into Rio Hato airstrip using a low-altiitude approach over water to avoid radar detection.

Committee sources said the panel plans to ask the State Department for its projection of Panamanian-Soviet relations after 2000. Moorer declined to sit with Zumwalt

Non-whites less healthy

WASHINGTON (UPI) - Nonwhites generally are less healthy than whites, but they get "less - and possibly less effective - health care," according to a Congressional Budget Office study.

"Despite considerable progress in narrowing the health gap between white and non-white Americans in the last 20 years, substantial differences persist," the study said.

"The health of non-whites is not as good as that of whites, vet non-whites get less -- and possibly less effective -health care than whites do," it said.

Non-whites include blacks, American Indians and Orientals. The term whites in the study applies to Caucasians and Hispanics.

Non-whites run up nearly 50°; more bed disability days, 70% higher infant mortality and a life expectancy 6 years shorter than that of whites, the study said, and whites make about 10% more visits to doctors than non-whites.

"I should say candidly that this asssessment differs with those of some other reports," he added. "Torrijos is clearly the leader ... When he chooses to make decisions, his will prevails ... Sharp, direct criticism of Torrijos is not accepted."

Mrs. Rose Marie Aragon — whose Panamanian husband, Leopoldo, immolated himself in Sweden last month to protest the treaties - disputed claims by U.S. negotiators that abuses had eased in Panama in the last few

She told the House committee her husband was arrested in 1972, sentenced to five years in prison and tortured at the "Devil's Island" penal colony before being exiled to Sweden.

Mrs. Aragon also presented the committee with documented cases of human rights violations through 1976, including the alleged torture of at least 151 persons.

A number of witnesses appeared before the Senate committee, including Robert M. Bartell of the conservative Liberty Lobby, which is strongly opposed to the treaties.

Airbag test suppression 'poppycock'

WASHINGTON (UPI) - National Highway Traffic Safety Administration officials say it is "poppycock" to suggest they suppressed results of an airbag test and threatened reprisals against an engineer who tried to make the results public.

Officials say the charge of suppression, reported Monday by the Detroit News, initially was made in a memo by NHTSA engineer Thomas Glenn. NHTSA attorney Frank Berndt says Glenn since has told him the accusation "was unwarranted."

Berndt and other NHTSA officials denied reports, attributed by the News to congressional investigators, that Glenn was threatened with disciplinary action and was refused permission to deliver a professional paper.

Officials acknowledged test results in question, which were made public Sept. 2, showed seat belts gave marginally better protection than airbags under the conditions being tested. They said the test seatbelts were cinched tighter than humans would wear them and the airbags were an old type that has been improved.

"To suggest suppression (of the test results) is sheer poppycock," NHTSA chief Joan Claybrook said Monday. Glenn could not be reached for comment.

Transportation Secretary Brock Adams has ordered airbags or other passive restraints installed in some cars by the 1982 model year. His order, strongly opposed by Rep. John Dingell, D-Mich., and some other lawmakers, will take effect Friday unless both the House and Senate disapprove.

The tests that prompted the dispute were conducted for NHTSA by Calspan, a private research firm in Buffalo, N.Y. They involved offset crashes of cars traveling 30 miles per hour.

Berndt, Ms. Claybrook and her special assistant, Carl Nash, disputed reports that the agency withdrew the test results from its public docket after Glenn placed them there.

They said Glenn took a test report to the docket room, bypassing normal review procedures, but it was intercepted by the docket clerk and reviewed before it was made public. The review took a week, much less than normal, and then the results were placed in the docket, they said.

According to sources quoted by the News, dummies and cadavers used as test subjects in cars equipped with seat belts survived with injuries below the limits set by the agency. The sources said dummies and cadavers in cars with airbags would have been killed had they been living humans.
