# Michigan man sentenced in killing of lover's spouse

Wife, victim are ex-C.R. residents

Special to the Gazette ALLEGAN, Mich. — Fifty-one weeks after he played a role in shooting and killing his lover's husband, a 19-year-old man was sentenced Friday to 25 to 50 years in prison.

Before sentencing Dennis Lee Leonard, 19, for the killing of James Lundgren, Allegan County Circuit Judge George Corsiglia asked Leonard why he would have anything to do with Kimberly Lundgren, his ex-girlfriend whom he agreed to testify against.

"I loved this lady, but I can't

Leonard, who showed no emotion during his sentencing Friday. "I don't know why myself."


Lundgren, formerly of Cedar Rapids, will be sentenced next week in connection with the Leonard and Lundgren were charged with the shooting death

of her 42-year-old husband,

James Lundgren, as he slept

July 30, 1993, at the couple's Fillmore Township home. Leonard, who, according to court records, has the maturity of a 12-year-old, originally admitted shooting Lundgren. Later he said it was actually Kimberly Lundgren who fired the shot after he refused. He pleaded guilty to second-degree murder.

Kimberly Landenberger Lundsay why, your Honor," said gren, 33, who also pleaded guilty



to second-degree murder, will be sentenced July 28 by Circuit Judge Harry Beach following a hearing on her pre-sentencing report. She claims Leonard was the shooter.

The Lundgrens moved to



Michigan from the Cedar Rapids area about eight years ago.

Judge Corsiglia said he believed Leonard was manipulated by the older, more experienced Lundgren, but quickly added, "That doesn't excuse what you did. You had an opportunity to walk away. You didn't do it." Following the sentencing,

Ruth Swick of Marion, James Lundgren's sister, spoke on behalf of the victim's family. "We're pleased, maybe even a little shocked he got that long. All we hope is that Kim gets what she deserves, life (in prison) and nothing less.

During the court appearance, Swick told the judge that while Leonard was "in the clutches" of Kimberly Lundgren, he failed to stop the crime which claimed the life of her 42-year-old brother and robbed the Lundgrens' two young children of both par-

Nevertheless, Swick said she can accept Leonard's apology because he apparently did not

play the lead in planning or carrying out the shooting.

The shooting took place on the eve of what would have been the Lundgren's 12th wedding anniversary.

The shooting came as a surprise to family members, who were not aware of any significant marital problems, said Jamie Lundgren, James Lundgren's 17-year-old daughter, who: lives in Toddville.

Kimberly Lundgren's attorney and family members have argued she was a battered wife who chose homicide as her only escape. But police and prosecutors allege the slaying was a clumsy lovers' scheme to get Lundgren out of the way and collect on his \$100,000 life insurance policy.

## C.R. man who gave baby snuff gets probation

Lightfoot's attorney contended his client was incompetent to stand trial. At a competency hearing, Jack Baker, a psychologist, testified Lightfoot has an IQ of 60 and is illiterate. An IQ of 100 is considered average.

Judge August Honsel ruled in March that Lightfoot was competent to stand trial, but it was unnecessary after the plea bargain was reached.
