UI lab joins bioterrorism fight

The school will get \$280,000 for joining the CDC network

Gazette staff writer IOWA CITY — Bioterrorists struck a Tokyo subway several years ago. The Iraqi government has used chemical weapons against its own people. And bioterrorist hoaxes have occurred

As the threat of easily obtainable biological and chemical weapons — sometimes called "the poor man's nukes" — changes from the stuff of Hollywood movies to an everyday reality, the University of Iowa expects to play a key role in the fight against bioterrorism.

The UI's Hygienic Laboratory has become part of the National Laboratory Network for Bioter-rorism Detection launched by the Centers for Disease Control and Prevention (CDC) last month.

The UI lab will help on a state and national level, said Mary Gilchrist, thé lab's director.

It is one of 40 labs around the country designated to conduct tests on biological agents submitted from other hospitals or labs.

The additional tests will help determine if the agent may be related in some way to a bioterrorism event.

"We are becoming more and more aware that the possibility that a bioterrorism event will become a reality," Gilchrist said.

Experts say that when it comes to bioterrorism network and led a group of microbiologists from events, it is no longer a matter of if, but of when, she added.

In addition to testing samples from other labs and hospitals around the state, the UI Hygienic Laboratory will serve as a test site for the CDC.

As more efficient methods emerge to speed up the identification of suspected bacteria and viruses, the UI lab will evaluate them and determine how well they work. The \$280,000 the UI will re-

ceive over the next year to be part of the network is part of a \$40 million effort unveiled by the CDC in September.

The money, which went to states and major cities, will help communities improve their public health infrastructure.

Nearly \$8 million went to improve the capacity for dealing with biologic agents at labs, like the

The 127 projects funded by the CDC will have benefits beyond simply helping to address bioterrorism.

"Every dollar we spend on preparing public health locally for the possibility of biological or chemical release among their civilian population is also a

dollar that helps reinvigorate our public health infrastructure," said CDC director Jeffrey Koplan.

Chevrolet Suburban head-on. Rich was listed in fair condition Friday afternoon at University Hospitals. The five students riding with Harris were treated for cuts and bruises but were not admitted to a

Contrary to a statement by one of the passengers, the seat belts in the school vehicle's middle seat were functioning, David Harris said. He said he went Friday morning to the garage where the vehicle had been towed to test them.

"All six of them in the front two seats, they snapped and worked fine," he said. Harris said the students may have confused the 1991 Suburban in Thursday's accident with a 1984 model in the district's fleet. The older truck's belts were repaired recently,

Barbara Harris and the students riding in the front seat were wearing their seat belts.

tance of the 17year-old Pittman in Davenport in September 1980 when she was beaten and strangled to

death. Her body was left at a Highway 30 rest area near Clarence. Tumey was a suspect early on, confessed in 1990, and reaf-

firmed the confession in 1992. But he wasn't arrested and charged with first-degree murder until this May.

At trial, his attorneys argued that Tumey's confessions were either the delusions of paranoid schizophrenic or the exaggerated rantings of a longtime mental patient seeking attention.

In August, in an interview with a psychiatrist for the prosecution, Tumey said he did not kill Pittman but saw three men beat her to death.

Defense attorney Brad Norton of Lowden said Friday he had not decided if he would seek to move the trial to another county because of news coverage of the first trial.
