# Search on for man seen driving dead lowan's car

EFFINGHAM, Ill. (AP) - Law enforcement officials are looking for a slender man in his 30s who was seen driving the car of an apparent Iowa murder victim.

The car was found late Monday in a church carport in Effingham, in south-central Illinois. It was first seen near the church Sunday evening, just one day after Arnold Sansgaard's body was found in the living room of his home about a mile west of Story City, Iowa.

Dr. Thomas Bennett, Iowa medical examiner, said Sansgaard died of multiple stab wounds, probably on July 14, a week before his body was found.

Sheriff Henry Wallace of Boone County, Iowa, said Tuesday that someone was seen driving Sansgaard's car July 16 in east-central

Minnesota, northeast of Minneapo-

Wallace said the driver was described as about 6 feet tall, slender, possibly wearing glasses and having dark brown hair that covered part of his ears.

Wallace said he had no idea who the man is or if he is a suspect, "but we would like to locate him and talk to him.'

Wallace said two Chisago County, Minn., deputies had stopped the man in the car July 16 about 15 miles north of Center City, Minn. They made a routine check of the car's registration and no citation was issued. The car had not been reported missing at the time because relatives assumed Sansgaard, 58, had taken a trip somewhere.

## Judge changes mind on lowa-Illinois rate increase

DAVENPORT (AP) — A Scott County judge Tuesday struck down almost half of an interim rate increase he had granted last month to Iowa-Illinois Gas & Electric Co., but left intact \$5,219,000 of the increase.

District Judge James E. Kelley ruled that the company had not shown sufficient grounds for the \$4.7 million portion of the interim electric increase the company said it would pay for excess generating capacity.

Iowa-Illinois had asked to collect \$9.9 million while the court is considering its appeal of a \$30.29 million permanent rate increase granted by the Iowa State Commerce Commission.

The \$9.9 million interim rate increase was on top of the \$30.29 million. Kelley approved the interim increase June 11, and Iowa-Illinois began collecting it June 13.

One district attorney called the case "the most frightening and bizarre criminal conspiracy I have ever seen. Higgins held up copies of Boston

Other defendants, the affidavits allege, urged a Boston police officer who had already pleaded guilty in' the case to flee to Canada before sentencing. He was subsequently sentenced to state and federal prison terms, and is expected to be a witness in the federal trials.

At the hearing for the men arrested in the Boston area, a federal magistrate ordered Donald Stackpole, Gregg Bemis and Wayne Sanden held without bail, and set bail for Ray Norton Jr. and Joseph Gorman at \$50,000 and \$25,000, respectively.
