Court sends ADM dispute to state

A dispute between the state and ADM Corn Sweeteners over its power plant in Cedar Rapids must be considered first by the appropriate state agencies before being taken to court, a Linn District Court judge ruled Thursday.

Judge Lynne Brady dismissed a petition filed by Archer Daniels Midland (ADM) asking review of the Iowa Utilities Board's actions regarding the firm's power plant in Cedar Rapids.

She sustained the Utility Board's contention that administrative remedies had not been exhausted prior to ADM's filing the court action. She sent the case back to the agency for further action.

requiring the petitioner (ADM) to wait for a review of final agency action," Brady's ruling said. ADM attorney Pat Roby said Brady's ruling "is not a ruling on the merits. We continue to believe that ADM is a private producer of its own electricity and not subject to the Utilities Board's jurisdiction."

"We just tried to get the question of their jurisdiction addressed first (in court) so we didn't spend a lot of time addressing something that may not come true," Roby added.

ADM has operated the \$60 million power plant since last

Last October the Utilities Board ordered a probe to determine if ADM violated Iowa law requiring

showing of irreparable harm by advance state approval for any electric generating plant of 100 or more megawatts.

The company contended then and still does, Roby said, that the law cited applies only to public utilities in Iowa and that ADM's plant is not a public utility.

Last December ADM asked the board to dismiss the case, claiming the agency had no jurisdiction. The board denied the request in April. ADM filed its judicial review petition in May, asking the court to review the board's action, reverse it and instruct the state to dismiss the case.

Roby indicated that if future administrative action by the state is adverse to ADM, it's likely another court action will be filed, again challenging the agency's jurisdiction.

Mortar Board honor society at Coe College has established a memorial fund to honor slain


