# Senator: Student aid inadequate

Gazette Johnson County Bureau IOWA CITY - The nation's student aid programs have not kept up adequately with increasing college costs, a U.S. senator responsible for some of those programs told a group of Big Ten university student leaders Saturday. (Related story on page 4B.)

"Many of our nation's most deserving young people are being priced out of college," Sen. Claiborne Pell said during a session of the Student Big Ten Conference, hosted this weekend in Iowa City by the University of Iowa Student Senate.

Pell is chairman of the Senate Education subcommittee and was a key figure in the establishment of federal student aid programs in the 1960s and 1970s. National Pell grants available to college students are named after Pell, a Rhode Island Democrat.

The federal government reversed its policies on student aid in the 1980s, shifting from grants to loans, and from offering more money to offering less, Pell said
