Police out of leads in Schappert murder

Cedar Rapids police have exhausted all available leads in the Brian Schappert murder case, and are again asking anyone with information on the Sept. 8 slaying to call the department.

Assistant Police Chief James Barnes said Friday the department has interviewed about 85 people either living in the area of the murder or who were in the area the morning of the murder.

Police have completed a check of more than 980 brown vans similar to one seen in the parking lot of the Kum and Go store, 2743 Mount Vernon Rd.

SE, about the time of the incident.

Schappert, an assistant manager at Kum and Go, was found dead in the store about 3:15 a.m. His throat was slashed and money had been taken from the store's cash register and safe. Two full-time detectives have

been assigned to continue the investigation.

Police are seeking a man who was seen in the store playing a video game about 2 a.m. He is described as white, in his mid-20s, approximately 6 feet tall, 170 pounds, with shoulderlength dark brown hair and two to three days' growth of beard. He was wearing a dark sweater and jeans.

Journalism to stay at ISU, Branstad says

Gazette Des Moines Bureau DES MOINES - The Iowa Board of Regents supports restructuring Iowa State University's journalism department but not eliminating the program, Gov. Terry Branstad said Friday.

Eliminating the ISU journalism program was one of several recommendations made by a consultant studying duplication at the three state universities.

The governor also indicated that other aspects of the Peat Marwick Main report likely will be passed over by the regents this fall, but he declined to be specific.

The regents should receive staff recommendations Monday for implementing changes in duplication of programs at ISU, the University of Iowa and the University of Northern Iowa.


R. Wayne Richey, the regents' executive secretary, refused comment on the governor's remarks or on the content of his report.

However, Regent Elizabeth Hatch, of Cedar Rapids, said "the governor is reflecting an informal consensus that we don't think (eliminating ISU journalism) should happen, but no formal decision has been made.'

20-ton cocaine cache seized



\$10 million cash also stashed in L.A. warehouse

LOS ANGELES - Breaking a \$6 padlock on an unguarded warehouse in the San Fernando Valley, drug agents Friday seized a cache of at least 20 tons of cocaine and more than \$10 million in cash in what they said was the biggest drug haul in history.

Officials linked the drugs, whose wholesale value they estimated at \$2 billion or more, with drug cartels operating out of Medellin and Cali in Colombia. They said three men were arrested and one was being sought.

The raid early Friday on the rented warehouse on a mostly residential street in Sylmar, Calif., was in response to a tip two days ago from a resident of Smylar who reported frequent traffic in big trucks, said officials of the Drug Enforcement Administration. The agents said the drugs were found in bricks wrapped in plastic inside brown cardboard boxes. Some of them were hidden in false panels of an unmarked white truck trailer that was parked outside, said John Zienter, the DEA's special agent in charge of the operation.


Big turnout for primary? Experts split

There's as much debate over whether Cedar Rapids voters will turn out in droves for this year's city primary Oct. 10 as there are candidates.

Linn County Auditor Linda Langenberg has ordered 30,000 ballots for the primary, which is just under a 50 percent turnout a big turnout for a primary.

Already, Langenberg has logged 80 requests for absentee ballots. She can't fill them until primary ballots arrive from the printer Monday. Two years ago, only 200 Commissioner Robert Jaeger and former



Two years of Police Department controversy and the four-way race for public safety commissioner have raised the interest in local politics, according to some political observers.

"In the past, interest in local government here has not been very high," said Dick Pitner, social studies teacher at Kennedy High School. That interest has been piqued, Pitner said, partly because "at least two of the candidates (incumbent Public Safety

commissioner Floyd Bergen) are willing to throw grenades at each other."

But controversy also can bring a certain weariness. People are getting tired of what they see and hear about city government, several sources said.

"It's not that they don't want to read about it," said public safety candidate J.D. Smith. "But they are concerned that the problems are not being solved, corrected, being taken care of."

Hinzman rethinks halfway houses

Conventional wisdom that halfway houses for adult criminals ought to blend into residential neighborhoods may become obsolete in Cedar Rapids, partly by circumstance and partly by design.

Plans for a campus of correctional services buildings on the west side of Cedar Rapids were revealed Friday by Gary Hinzman, director of the 6th Judicial District Department of Correctional Services.

Hinzman said he hopes the site will be remote enough to avoid protests by neighbors, who view such facilities as a threat.

The campus plan, devised by Hinzman and his citizen board of directors, would bring service agency representatives who are helping halfway house clients to the campus, rather than have clients seek those services in the community, as they do now.


The rationale, Hinzman said, is that clients need to have closer scrutiny and more convenient access in seeking help.

HINZMAN SAID the campus plan, in part, is founded on the belief that adult clients residing in correctional halfway houses

are different than those of just a decade ago. In 1989, the prison system is too stuffed to either take all the inmates it should or keep the ones it takes.

Today's halfway house clients need more rtructure and the community needs more distance from them, he said.

Bill Faches, a Cedar Rapids attorney who has chaired the judicial district's citizen board for 11 years, said Friday that the campus plan would bring to reality a dream the board has had for years of locating all services at one location and eventually owning the land and buildings.
