"Sometimes when I've driven down the highway and I have seen a young boy hitchhiking, I'll turn around and go back and take another good look at him. It's part of the hope I still hold."

Howard Heckle and his wife, Nancy, 1505 48th St. NE, still cling to the hope that their son, Guy, who was 11 when he disappeared, is still alive.

But Harry and Eloise Tickner of Minneapolis, the parents of a missing Cedar Rapids woman, are convinced that their daughter is dead.

Guy Heckle disappeared from a Boy Scout outing at a camp near Toddville on Feb. 3, 1973, and has never been seen or heard from since.

The Tickners' daughter, Lynn Schuller, disappeared from her home in Cedar Rapids, and was reported missing Aug. 7, 1972. She, too, was never seen or heard from again.

Both disappearances resulted in extensive searches and official investigations.

#### No indication

County Sheriff's Department said the boy's disappearance is unexplained. "No one has ever figured out what happened to him."

The boy's coat was found in the Cedar River, hooked on a log, a few days after he disappeared from the Scout camp, leading to speculation that he fell into the river. However, Neagle said "extensive dragging operations in the area never found any other trace of young Heckle." Neagle continued, "Hundreds of

volunteers searched the area in a criss-cross pattern, and we are 99 percent sure every square inch was covered within a mile radius of the camp. The Sierra Madre Search and Rescue Team also was called in and covered another four to five miles around the camp.'

Neagle said the Iowa Bureau of Criminal Investigation also conducted a thorough investigation along with his office, and Neagle concludes he doesn't know what more could have been done.

"We used every resource in the county — aircraft, horses, scuba divers, boats, foot searches checked out every lead, including possible abduction, but turned up nothing."

The Heckles agreed the investigation was thorough. "We are satisfied with the investigation — we don't know what more we could really ask for," said Howard Heckle, the boy's father.

## Still hoping

"We've never heard a word about what happened to Guy — it's just like blowing out a candle. But we haven't given up hope that he is still alive," Mr. Heckle said.

Nancy Heckle added, "I don't take off on his own.'

Lt. James Neagle of the Linn authorities there but have not heard a word from them.

"We haven't heard of any remains of boys that small being found, but time. we sent the records because Gacy was in the area at one time and could have driven through here on his way to Chicago."

Gacy lived in Waterloo for a few years before moving to Chicago.

Gacy reportedly told Chicago area authorities that he killed 32 male youths and buried most of the bodies in the crawl space under his house. About 27 bodies have been recovered, but only a few have been identified.

Meantime, Chicago Police Superintendent James O'Grady has ordered a computerized program to help police trace missing persons in connection with the Gacy case. The program would be limited to Chicago missing persons, but other Cook County, Ill., officials want it extended beyond the Chicago area.

#### Faith helped

Both Nancy and Howard Heckle said they adjusted to the loss of their son through deep Christian faith. Howard Heckle said his wife had such faith at the time Guy disappeared. "but I didn't — I became a Christian over the situation."

Mrs. Heckle said they've left the fate of their son in the "hands of the Lord. . . . He knows all about it and in time he'll let us know."

The Heckles say they can openly talk about their missing son. Mr. Heckle said he "can": remember a day when he (Guy) hasn't tugged at my heart — and I wouldn't want it any other way. We can talk about him and laugh about some of the funny things he did."

Although Heckle would be 17 think he ran away. His coat was now, his father said he would have found, and a boy that age just doesn't no trouble identifying him if he were to see him today.



Guy's disappearance — but they were a close family before that. Both to sympathize with other people's problems and some prejudices have fallen.

"I've learned to be more tolerant and to review my priorities as to what I was put on this earth for," Howard Heckle said.

## Foul play suspected

By contrast, Eloise Tickner of Minneapolis, the mother of Lynn Schuller, believes foul play was involved in her daughter's disappearance.

Lynn Schuller, according to the sheriff's records, was 26 when she disappeared. She lived at 3100 30th St. Drive SE with her husband Keith, then 31, and their young son, Eric, believed to have been about 3 at the

Lt. Neagle said investigative records indicate that Keith Schuller told authorities he and the boy left their home about 7:30 the morning of Aug. 6, 1972, to go fishing and that Mrs. Schuller was still sleeping.

They returned about 12:30 that afternoon and Lynn and her bicycle were gone. Schuller told authorities that he took Eric swimming shortly after that, returning home in about an hour. He found Lynn's bicycle then, but she was missing. Schuller,

Neagle said, "There were a lot of parents said they now find it easier suspicious circumstances around the case to indicate the possibility of foul play." He said the investigation showed she was not the type to just leave. Her purse was left in the house, along with her clothes. The only thing missing was the clothes she wore, Neagle said.

Authorities did obtain a search warrant for the Schuller residence soon after the disappearance, but none of the items seized were useful in determining Mrs. Schuller's whereabouts, they said.

Keith Schuller was arrested on a charge of refusing to assist an officer when he allegedly refused to assist four officers asking his cooperation in the investigation. The charge was dismissed in December 1972 for insufficient evidence.

Neagle said an extensive search for the woman was conducted. Even infra-red aerial photos were taken of various areas in an effort to determine if the earth had been dug up. The work by the Sheriff's Department and state BCI turned up no trace of Lynn Schuller.

## Cases still open

Asked the status of these cases, Lt. Neagle said they are still considered open - but acknowledged that not much has been done on either disappearance for the last four years or so. Neagle noted, however, if any new tangible leads do come to light, they will be investigated thoroughly.

Neagle asked anyone who may have any tangible leads in either case to call or write the Linn County sheriff's office. "They can remain anonymous if they wish," he added.

Currently, Linn County has 11 open cases of missing persons or runaways dating back to 1970. Neagle said several of these could be juveniles who have left home after a family dispute.

Cedar Rapids police list 26 missing persons at the present time, of which 20 are teen-agers.



Even though they still are hopeful that Guy is alive, the Heckles said they can't rule out that the boy may have fallen in the river or that foul play may have been involved in his disappearance.

The boy's father said that following the grisly findings near Chicago in the John Gacy case, the family last month sent Guy's dental records to help such a sick person."
