The Monroe County Extension Service and the Monroe County Farm Bureau are co-sponsoring a farm meeting Monday, Jan. 14 starting at 7:30 p.m. at the American Legion building in Albia.

The meeting will revolve around a question and answer period with resource people, Steven Roy, a Des Moines attorney, Don Carr, an Albia Certified Public Accountnat, and John Humphries FmHA district supervisor on hand to help answer questions.

Topics for discussion will include management survival, foreclosures, bankruptcy, loan forgiveness, tax liabilities involved with forclosures and loan forgiveness, and tax implications dealing with losses

'The emphasis on the meeting will be on constructive questions and answers," said Extension Director Gary Peterson who will also serve as moderator at the meeting "There will be no lectures and no political speechmaking from the floor. This meeting is a way to give our farmers some important information in dealing with the current conditions in agriculture.

Peterson said that farmers attending will be given cards to write anonoymous questions or may ask questions directly from the floor


Chamber annual meeting Jan. 21

Milligan missing for six months

The waiting and now knowing gets worse as time goes by, said Leonard Milligan in talking about his son, Harry Milligan, who has been missing since July

Milligan was last seen in the Albia business district between 3 and 3 30 a m on that Sunday. He was traveling north on Main Street in Albia and at that time was believed to be en route to his family home in Avery but failed to show up there Harry Dennis Milligan, 22, is

listed on the Iowa Department of Public Safety's missing persons list which was released last week. He is described as a white male six feet tall and weighing 160 pounds. He has brown hair and blue eves.

When last seen, Milligan was driving a maroon 1977 Pontiac Gran Prix with Iowa license plate number EIJ-244

Milligan's family has posted a \$500 reward for information

about his whereabouts and posters have been distributed nationwide. Leonard Milligan said that there have been rumors which have been checked out, but nothing definite has shown up to indicate Harry's whereabouts

Milligan said, "Losing our daughter (she died in August) hurt, but we know where she is and we can't bring her back " He added, "We've done all we can do to locate Harry and now we just sit back and wait We don't know what else to do don't know what I'd do if I wasn't working '

Authorities have been unable to confirm sightings of Milligan and have not been able to locate his car since he disappeared July 1 Persons with information concerning Milligan's possible whereabouts or with information of any type which may be of assistance is asked to contact the Monroe County Law Enforcement Center at 515-932

City Council discusses budget items

The Albia City Council began working on the 1985-86 budget at its meeting Monday night

Before budgeting a subsidy for the Monroe County Ambulance Service, council members requested that Les Campbell present a financial statement of his past six months of operations

Other major items under consideration for the budget are purchase of a new endloader, a pickup for the street department, sound equipment for community use, dues for the Regional Planning Commission support for the Integrated Tran sit System, support for recreational activities and city pay raises

In other business, the council set the next meeting for 7 p m Tuesday Jan 22 in order to avoid conflict with the annual Area Chamber of Commerce dinner meeting on Jan 21
