Psychiatrist faces Iowa sex exploitation charge

Iowa City practice denies charge

Gazette Johnson County Bureau IOWA CITY — A former Iowa City psychiatrist is charged with sexually exploiting one of his patients at the Mental Health Center of Iowa City.

But James Wilcox, 39, now of El Paso, Texas, denies the charge and says he is the victim. Wilcox is scheduled to be arraigned in Johnson County District Court at 1:30 p.m. Wednesday.

According to a memorandum filed last week by the County Attorney's Office, Ann Nicholson, also of El Paso, states that Wilcox was her therapist at the Mental Health Center from 1991 to 1994.

Texan who had an August 1994 but, Nicholson stathis behalf. ed, called her when he was in Iowa City briefly in September 1994. The two began a sexual relationship, she stated, adding Wilcox sent her letters that referred to their relationship. Nicholson states she moved to El Paso in February to live with Wilcox.

> The memorandum also includes testimony from Dennis Carr, associate director of the Iowa Board of Medical Examiners, who stated he received a complaint from Nicholson about her relationship with Wilcox.

Carr stated he met with Wilcox last spring and Wilcox told him he had fallen in love with Nicholson and planned to marry her. However, Wilcox told Carr that Nicholson had left him after Wilcox visited his estranged

"Mr. Wilcox was engaged to Miss Nicholson and was involved in a serious relationship during which she sent him graphic sexual pornographic let-

ters to seduce him," Harris said. Harris called the charges against Wilcox "preposterous." The statute of the code with which the county attorney is trying to charge Wilcox doesn't even apply, she said. She said Wilcox was not Nicholson's therapist, but instead prescribed medicine for her stage fright.

Documents on file with the state Board of Medical Examiners - where proceedings are pending against Wilcox — indicate the female patient had been diagnosed with mixed personality disorder with elements of borderline personality disorder, passive/aggressive disorder and narcissistic traits.

Coralville police link man to C.R. robbery

A man arrested in Coralville faces charges in connection with the robbery and attempted robbery of two Cedar Rapids convenience stores.

Daniel L. Hodges, 34, of 900 Ninth St. SW, was taken into custody on unrelated warrants just after midnight Monday when Coralville police responded to a call of a loud party. Police would not say how they linked Hodges to the Cedar Rapids incidents.

Cedar Rapids Police Lt. Joe Hanrahan said Hodges faces two counts of first-degree robbery. He is accused of robbing the Kum & Go, 2743 Mount Vernon Rd. SE, about 4:40 a.m. Sunday. Police say the suspect in that case was armed

with a handgun. Hodges is also accused of attempting to rob the Kwik Shop, 3301 J St. SW, just minutes after the Kum & Go robbery.

According to police, a man entered the store, displayed a gun and demanded money. However, the clerk ran into the office, locked the door and called police. The man left without the money.

Hanrahan said a third robbery Sunday morning at the Comfort Inn, 5505 Rockwell Dr. NE, is still under investigation.

A man armed with a handgun robbed the front desk of the motel at 2 a.m.

Coralville Police Sgt. Bruce Freeman said officers interviewed Hodges after being called about a disturbance at a home where he had been staying.

The warrants on which Hodges was previously wanted charged him with two counts of forgery, second-degree burglary, delivery of a controlled substance and being a habitual offender. He was also charged with assault while displaying a

sion benefits in Iowa.

In its recent ruling denying the fees, the Supreme Court noted that Shuttleworth & Ingersoll originally agreed to an hourly fee arrangement, then later advanced a common fund theory for paying legal fees, if the case was successful — meaning the firm would get 5 percent of the total award.

Streit and Kutzko made the 5 percent claim after the Supreme Court awarded the \$33 million, from which they should be paid.

The Department of Revenue and about 40 retirees protested the attorneys' claim at a court hearing. In April 1994, District Judge Lynne Brady approved the claim and ordered the Iowa Department of Revenue to pay 5 percent or about \$1.65 million to

the firm.

The Department of Revenue and six retirees, including former Senior Federal Judge Edward McManus of Cedar Rapids, appealed Brady's order to the Iowa Supreme Court.

In reversing Brady's order scuttling the large fee award, the Supreme Court recently said there was no common fund, that all 13,000 retirees are treated and paid as individual claimants.

lected unlawful taxes from federal workers. In those cases, Streit said, the lowest attorney fee allowed was 15 percent of the total award. For instance, attorneys in Arkansas got 15 percent of \$40 million, he said.

Streit said there will be no appeal of the Supreme Court's ruling. As a result, Shuttleworth & Ingersoll will be paid on an hourly basis and receive about \$50,000 from the National Association of Retired Federal Retirees in Iowa.

"The association only represents about a third of all the federal retirees in the state, so there are a lot of people out there getting this refund without it costing them anything," Streit said.

Though the original Supreme Court ruling came down two years ago, Streit said none of the retirees has been paid yet. The state was waiting until the Supreme Court ruled on the fees question, he said. Streit said he's written a letter to the Department of Revenue asking it to begin making payments.

C.R. board cool to plea on calendar

For the first time since questions about the school calendar were raised last October, members of the Cedar Rapids school board have expressed their views on the matter.

During discussion last night. Doug Henderson was the only board member sympathetic to views of district residents unhappy with the scheduling of this year's spring break.

The break is slated for March 25 to 29, and for the first time in at least 12 years, Cedar Rapids students will attend classes on Good Friday, April 5.

"Maybe this is an area in the future where we can have some compromise," Henderson said.

LORI HAYS, a parent and supporter of a petition drive that asks the district to continue to recognize Easter as a holiday, was one of three district residents who addressed the board again last night. Hays presented more petitions and said signatures now total nearly 2,000.

Henderson noted that Cedar Rapids is the only district in the metropolitan area whose spring break is not scheduled on days surrounding Easter. He called for better communication when future calendars are formulated.

Iowa City schools will break from March 18 through 22.

Other board members said they considered it a good idea to schedule spring break the same week each year, the fourth week of March. The Easter date varies, they pointed out.

Board member Susan McDermott said schools across Iowa do not have a common spring break. Students need a break by the end of March, board member Mary Ann Kucera added.

NO BOARD members were interested in changing calendars already approved by the board through 1997-98.

In other action, the board gave first approval to a weapons policy proposed by the administration. Under the policy, students who take firearms to school will be expelled for one

Court upholds murder conviction of teen

DES MOINES (AP) — The attempted murder conviction of CLAYTON COUNTY a Clayton County man who attacked a youth with a machete after watching a movie in which a machete was used has been upheld by the state appeals court.

Shane Suomala had claimed the June 1993 attack on his 10-year-old neighbor came after he was drinking beer and watch-

ing men cut sugar cane with a machete in the movie "Delta Force II."

"Something came over me. I don't know what it was," Suomala said, according to court records. "I went into my room, and on my wall I had a machete. And I grabbed it and I went

downstairs and outside."

Suomala, age 19 at the time, ery Walter, who lived near Suomala. The boy's skull was dented, and he suffered numerous stab wounds court records said. Part of a finger was severed. Suomala was convicted by a Clayton County District Court jury and sentenced to up to 25 years in prison.
