Misdemeanor cases Action has been taken on the following misdemeanor cases in Linn County District Court:

Charles A. Kelsey, 24, of 441 Lindale Dr., Marion, charged with assault causing bodily injury (domestic abuse), penalty enhanced, pleaded guilty to a lesser charge of simple assault (domestic abuse), penalty enhanced. Kelsey was accused of assaulting Stacy Dudley on March 1996. He was fined \$250, sentenced to 30 days in jail with all but two days suspended, and placed on probation. Curtis G. Miller, 23, of 1270 20th Ave. SW, charged with assault causing bodily injury (domestic abuse), penalty enhanced, pleaded guilty to a lesser charge of assault causing bodily injury. He was accused of assaulting his grandfather, Richard Miller, on Feb. 12. The defendant was fined \$250.

An Alford plea allows a defendant to plead guilty but not necessarily admit to all aspects of the charge.
