Noel Miller and her boyfriend, Casey Frederiksen, lived together at 1781 Quarry Road, Apartment #4 in Floyd, Iowa with their two young children and five year old Evelyn Miller. Evelyn Celeste Miller was born August 22, 1999, and was the daughter of Noel Miller and Andy Christie.

Evelyn's father, Andy Christie planned on picking up Evelyn on July 1, 2005, for a weekend visitation.

On Friday July 1, 2005 at 6:46 AM, the Floyd County Sheriff's Office received a 911 call from Noel Miller. Miller said that she returned home from work and found Evelyn, missing.

Miller had worked third shift at the Nora Springs Health Care Center in Nora Springs, Iowa as a CNA from 10:00 PM, Thursday, June 30, 2005, until 6:00 AM. July 1, 2005. Miller left for work around 9:45 PM and Frederiksen stayed home to watch the children.

Miller returned from work at 6:19 AM, went to the bathroom, and then noticed that Evelyn was not in the apartment. Miller said that she asked Frederiksen where Evelyn was and he said that he last saw her at 2:00 AM. Frederiksen said that he had changed the boy's diapers and that Evelyn had been asleep on the loveseat in the living room.

The Floyd County Sheriff's Office responded to Noel's call and began a search for the missing girl. A full scale search commenced as well as an investigation into Evelyn's disappearance. As part of the investigation, Frederiksen was interviewed by police. Frederiksen told police that he used to work at Kmart but had quit about a month ago and was a stay at home caregiver for the kids. He said he was watching the children on the night of Evelyn's disappearance and went to bed around midnight. He said that he awoke and fed the boys around 2:00 a.m. and then went back to sleep. Frederiksen said that his computer was "kind of broken down right now" and that there was only a single pornographic DVD that belonged to Noel in the house. Frederiksen said that he didn't drink much alcohol and denied using drugs. Sometime following the interview a search of Frederiksen's apartment turned up drugs, drug paraphernalia and scales. When Frederiksen learned law enforcement was going to search the apartment, Frederiksen head butted a wall and split his forehead open and screamed at police. Evelyn was not located on July 1, 2005.

A neighbor assisting in the search for Evelyn Miller called Dan Slick. During the conversation Slick indicated that he and Randy Patrie had seen Evelyn Miller when they

stopped by Frederiksen's apartment in the early morning hours of July 1, 2005. To the best of their knowledge, Slick and Patrie put this contact at approximately 2:30 a.m. Both Slick and Patrie stated that they knocked on the door, Evelyn answered, and she was fully clothed. Evelyn was asked if Frederiksen was there and she indicated that he was sleeping. Both Slick and Patrie left the apartment building and eventually returned to their residence in Charles City.

While hundreds of people searched for Evelyn on Saturday July 2, 2005, Frederiksen left with a friend and drove to Des Moines and then Waterloo. Frederiksen was reluctant to talk about his trip with police.

The search for Evelyn continued daily until Wednesday July 6, 2005, at 7:40 PM, when two kayakers discovered Evelyn's body in the Cedar River between Charles City and Floyd. Evelyn was found fully clothed. Information concerning the condition and state of Evelyn's body was never made public.

Over the next month Frederiksen was interviewed by police and changed his story regarding what he had done during the day that Evelyn had disappeared. Frederiksen continued to deny any involvement in methamphetamine use or sales.

On July 7, 2005, Dr. Jerri L. McLemore, Deputy State Medical Examiner, conducted an autopsy at the State Medical Examiner's Office in Ankeny, Iowa. Dr. McLemore ruled the manner of death as homicide and the cause of death as sharp force injuries, including wounds to the neck. There was also evidence of sexual assault. Law enforcement did not release these findings to the public.

On July 18, 2005, during a search with K-9 search teams, a K-9 alerted to an area near the Cedar River that was upstream from where Evelyn was found. Helicopter pilots from the Cedar Rapids Police Department had advised earlier in July that this area was the most likely area for Evelyn to go into the river. This determination was made due to the generally inaccessible nature of the banks of the Cedar River up-stream from where Evelyn Miller was found. The site identified by the Cedar Rapids Police officers is about 1.5 miles in a straight line from the Quarry road apartment. It is accessible by car or on foot. In June of 2010, Deputies later walked from the apartment to the river and back and completed the walk in about an hour and 25 minutes. The walk was conducted in similar conditions to the night of the disappearance.

On July 31, 2005, Frederiksen and Miller moved from the Quarry Road apartments. On August 4, 2005, a neighbor turned over a computer hard drive that been given to her earlier by Frederiksen. The investigation determined the hard drive contained child pornography. Hundreds of images and videos depicting violent rapes and sexual assaults of infants and children under the age of seven were contained on the hard drive. Investigators determined that Frederiksen's computer was operational and connected to the internet the night Evelyn Miller disappeared.

A witness stated the hard drive was given to the neighbor on the morning of July 1, 2005. Earlier that morning between 6:30 a.m. and 7:30 a.m. a witness reported that Frederiksen borrowed a screw driver from him and the neighbor. A screw driver would be necessary to remove the hard drive from Frederiksen's computer.

Randy Patrie reported to police that Frederiksen confronted him on September 3, 2005, outside the Good Times bar with a six to seven inch knife and accused him of killing Evelyn.

In September 21, 2005, Frederiksen tried to commit suicide by slicing his arm with a knife. During a hospital transport, Frederiksen said that if he could take it all back he would and he would be dead and Evelyn would be alive.

On November 5, 2005, specially trained FBI canines alerted to Evelyn's scent along the river. This location is in a straight line approximately 1.5 miles from the Quarry Road Apts. This is the same area previously noticed by the Cedar Rapids Police helicopter pilots. The FBI dogs also alerted to Frederiksen's scent at that location. The canines were given the scent of Randy Patrie and they failed to alert on his scent.

In 2006, Frederiksen pled guilty to federal child pornography charges and was incarcerated. While incarcerated, Frederiksen had contact with various inmates.

In the spring of 2006, Inmate #1 told authorities that Frederiksen would cry and say "I'm sorry Evelyn" to himself. Inmate #1 was incarcerated with Frederiksen at the Linn County jail. Frederiksen told Inmate #1 that Evelyn had told her stepmom that she had been sexually abused. Frederiksen talked of suicide attempts using a knife, fishing in the river and stealing a Gerber knife and prescription medication along with pseudoephedrine from Kmart while he worked there. Frederiksen told Inmate #1 about confronting Randy Patrie outside a bar in Charles City. Frederiksen was carrying a knife which he pulled out and asked Patrie why he had stabbed Evelyn in the neck. The nature of the injuries to Evelyn Miller had not been released to the general public by law enforcement.

In August 2006, Frederiksen told Inmate #2 that although he did not kill Evelyn, but he did touch her dead body and helped to carry her to the river. Inmate # 2 was incarcerated with Frederiksen at the Bremer County jail in Waverly, IA.

In November 2006, Frederiksen told Inmate #3 that he had been molesting Evelyn since she was a little girl and it continued until her disappearance. Frederiksen called Evelyn a "little bitch." Inmate # 3 was incarcerated with Frederiksen at federal prison.

On January 30, 2007, Frederiksen told police that the only reason someone would take a child would be to molest them.

On February 21, 2007, Frederiksen told police that Randy Patrie had taken Evelyn at knifepoint and never brought her back. Frederiksen said that he stayed up the rest of

the night and pretended to be asleep when Noel got home. Frederiksen admitted to enjoying watching men perform sex acts on small children, especially small girls. Frederiksen told investigators that although he never acted upon it, he would become sexually aroused changing Evelyn's diapers. Frederiksen later recanted his story about Randy Patrie taking Evelyn.

On March 5, 2007, Frederiksen told police that the night that Evelyn had disappeared, he had stayed up the entire night. He said that he had watched child pornography on his computer became aroused and masturbated approximately 15 feet from Evelyn. Frederiksen said that his biggest weakness to child porn were those that depicted grown men having sex with 5-7 year old girls.

On July 3, 2007, Frederiksen told his sister that he had made up the story about Randy Patrie taking Evelyn. He said that Patrie did come over but he left without Evelyn.

In the fall of 2007, Frederiksen told Inmate #4 that he had been sexually abusing Evelyn. Frederiksen said that if he told authorities what he knew he would get a life sentence. Frederiksen told Inmate #4 about threatening Randy Patrie with a knife. Frederiksen was incarcerated with Inmate #4 in federal prison.

In October 2007, Frederiksen told Inmate #5 that Evelyn was found with her clothes on. This information was not released by law enforcement. Frederiksen was incarcerated with Inmate # 5 in federal prison.

On June 3, 2009, Frederiksen was indicted and pled guilty to federal drug charges for stealing pseudoephedrine from Kmart and giving the pills to Candice Peck in exchange for methamphetamine

In the summer of 2009, Frederiksen was with Inmate #6 at the Bremer County jail in Waverly, IA, when he received his indictment for federal drug charges. Frederiksen laughed and said "get away with murder and still do life." Frederiksen also asked Inmate #6 "What would you say if I told you that I had done it." Frederiksen refused to talk further with Inmate #6.
