Branstad, Junkins disagree on whether budget cuts are likely

DES MOINES - Iowa's two gubernatorial candidates clashed over the condition of the state treasury Wednesday in separate appearances before a group of government administrators.

Democratic candidate Lowell Junkins warned the administrators that they face a "November surprise" from incumbent Republican Gov. Terry Branstad in the form of more state budget cuts as soon as the election is over.

He claimed the state is running a \$70 million budget deficit that could grow to \$140 million, necessitating spending curbs.

But Branstad, who has cut state budgets across-the-board twice, maintained no more such cuts will be necessary.

"I don't believe it's going to be necessary again because of the reorganization and downsizing we've had in state government and because the economic development efforts we're making have begun to pay off," he said.

Revenue is "achieving expectations" for this year, he said.

The two candidates, in separate appearances before the Iowa chapter of the American Society for Public Administration, also presented differing views of the reorganization of state government proposed by Branstad and approved by the Legislature this spring.

The governor called the reorganization of state government into 24 state agencies "one of the most significant changes in state government in the history of our state."

He repeated his earlier claims that it will save \$40 million a year in state administrative costs.

But Junkins termed it a "52-card shuffle" of government agencies

Files 3rd appeal of murder ruling

A Maquoketa man has filed a third challenge to his 1981 firstdegree murder conviction.

Clayton Manning, 33, is serving a life sentence in the Iowa Penitentiary at Fort Madison in the Jan. 2, 1981, shooting death of Phillip Clary, 34, of Zwingle. Clary was found in a ditch near Fulton, Iowa, with a gunshot wound to the head, and died later in a Dubuque hospital.

The Iowa Supreme Court affirmed the Jackson County District Court conviction in 1982. A civil post-conviction suit in the same District Court was denied last October.

The third challenge is contained in a habeas corpus suit filed in U.S. District Court in Cedar Rapids Tuesday. Habeas corpus is a writ or order requiring that a detained person be brought before the court to decide the legality of his deten-

The challenges have centered on Manning's claim that some of the evidence used against him was seized illegally from his jail cell. He was serving time on an earlier charge when he allegedly arranged to have his cellmate kill Clary while they were out on work release. A second defendant, Leonard

Gregory, 25, told jurors at Manning's trial that he shot Clary after Manning offered him \$500 and a car. Gregory said Manning told him he needed a "hit man" because Manning was having an affair with Clary's wife and he needed someone to get rid of Clary.

Gregory also was found guilty of first-degree murder.

jobs elsewhere.

raising the 4 percent sales tax: • They split on the need for a "super board" representing all levels of education, with Junkins saying he would bring all levels of education together in January and Branstad saying he wants to wait until a Legislature-mandated study on education is completed later this

AMES (AP) - Thanks to the success of the "7-11-21" instant lottery game, some retailers sold all of their tickets and began selling tickets in the new game last weekend, four days before Wednesday's official start.

In general, we don't approve of selling tickets until a game has officially started," said lottery Director Ed Stanek. But the previous game sold out — the first one to do so — so the lottery was faced with letting retailers sell the new tickets prematurely or sell no tickets at all.

The new instant lottery game, inaugurated at Iowa State University Wednesday, is called "Autumn Gold" and will be touted in commercials by Iowa native Roger Williams, who gained fame with his song, "Autumn Leaves."

Stanek said Williams didn't charge much for the use of his name and services. "It was very little," Stanek said. He said Williams was approached about the promotion when he performed at the Iowa State Fair this summer. "To our delight, he complied," Stanek said.

The game has a top prize of \$50,000 — more than the maximum \$21,000 in the previous game but lower than the highest instant prize of \$86,000 in a game this summer. The possible prizes are a free ticket, \$2, \$10, \$100, \$250, \$500 and \$25,000, with the prizes doubled on cards with a gold coin.
