Vander Esch files motion for dismissal: witness files civil suit

A motion to dismiss sexual abuse charges against Lawrence Vander Esch has been filed with the Sioux County Clerk of Courts office. Sioux County Attorney Mark Schouten filed a resistance to the motion the following day. The motion will be heard in District Court as part of a pretrial motion on May 29. Vander Esch is charged with four counts of felony third-degree sexual abuse. Depending on the outcome of the motion, Vander Esch is scheduled to stand trial beginning June 5. Twenty-three witnesses have agreed to testify against him. One of those witnesses, Nicholas P. Landman, has filed a civil suit against Vander Esch and the Pizza Ranch Corporation he cofounded. Landman is charging Vander Esch with assault and battery. He is charging Pizza Ranch with negligence. Landman claims he was assaulted in June 1998 when he was an employee of Pizza Ranch and he traveled overnight to Pella, Iowa with Vander Esch to retrieve a pizza delivery vehicle.
