### No Details, Ownership Of Truck Determined

IOWA CITY — The ownership of the truck in which two charred bodies were discovered Monday near the Coralville reservoir has been determined, according to Johnson county Sheriff Gary Hughes. Hughes, however, declined to disclose the identity, explaining the owner "has not been located. We are attempting to obtain dental records on the owner." The bodies of a man and woman found in the scorched pickup truck by two motorcyclists were so extensively burned that identification may depend solely on dental records, according to investigators who viewed the bodies. ### Expert: Busing Speeds Cities' "White Flight"

BOSTON (AP) — Sociologist James Coleman says "white flight" from cities where courts have ordered school desegregation is 14 percent greater than normal. "The greater the disparity between the racial composition of the central city and the suburbs, the greater the acceleration of white loss," Coleman wrote in a five-page affidavit filed in a U.S. court of appeals case here Tuesday. Coleman said that in a city like Boston, which is at least 35 percent black, a reduction in segregation by busing or other means will accelerate white flight 14 percent over normal rates.

### Indeterminate Sentence in Theft Case

A one-time Cedar Rapids resident who has been held in Linn county jail for nearly two months was given an indeterminate federal prison sentence Wednesday in Cedar Rapids federal court.

Dennis Daringer, who had lived at 1933 Higley avenue SE before being jailed on state larceny charges last year, was sentenced to the indeterminate term under the youth corrections act after pleading guilty to possession of a stolen car transported in interstate commerce.

Daringer, 25, was indicted by a federal grand jury last November on two stolen car counts. The second count of the indictment and another charge of failure to appear were dismissed Wednesday by the government. The latter charge was brought after Daringer left the country for Brazil. He was arrested on his return to the United States in July.

He faces a prison sentence not to exceed six years at federal youth corrections facility.

### Former Iowan's Death Is Ruled a Suicide

ANAMOSA — Neal Robert Townsend, 29, Pocatello, Idaho, a former Anamosa resident, died Monday morning in his Pocatello apartment. Idaho medical authorities ruled the death a suicide. Townsend, the adopted son of Mr. and Mrs. Neil Townsend, Anamosa, had been serving on the police force in Pocatello.

### Large Haul For Thieves

A breakin during the last three days at the Eli Abodeley residence, 4217 First avenue SE, netted thieves more than \$3,888 in stereo equipment and other items, according to a police report. changed her sentence to up to ten years at Rockwell City. What happened, according to Kopecky, is that the legislature changed the law. Prior to this year, the law stipulated that a female could not be incarcerated more than 30 days in a county jail. Any sentence greater than that automatically sent her to Rockwell City. Linn Sheriff Walter Grant claims the women's lib lobby got the legislature to change the law so a woman can be held in a county jail up to a year — just like

a man. But most county jails in Iowa are a great deal less appealing than the women's reformatory. The statute allows the judge to sentence either to the county jail or, in this case, up to ten years in the reformatory. Gardner took the ten years rather than six months in the county jail. However, officials in the county attorney's office hastened to point out that she is not likely to serve ten years. "She probably be placed on parole in eight months or so," said one.
